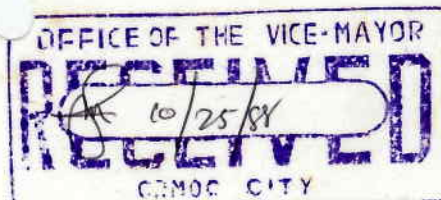

RESOLUTION NO. 105

A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR, MA. VICTORIA L. LOCSIN TO CREATE A SPORTS BODY IN ORMOC CITY TO BE KNOWN AS THE ORMOC CITY YOUTH AND SPORTS DEVELOPMENT COUNCIL.

WHEREAS, it has been the policy of the city government of Ormoc to create a Sports Committee to develop the physical abilities and skills of the youth in the field of sports;

WHEREAS, for so many years sports development program in Ormoc City has been solely in the hands of the Department of Education, Culture and Sports, while in other cities the local government unit had long undertaken the development of the youth in the field of sports;

NOW, THEREFORE, on motion of Kagawad Celso P. Adolfo, jointly seconded by Mga Kagawad Eufrocino C. Codilla, Jr., and Arnulfo C. Salazar; be it

RESOLVED, to earnestly request the Honorable City Mayor Ma. Victoria L. Locsin to create a Sports Body in Ormoc City to be known as the Ormoc City Youth and Sports Development Council which shall coordinate the different sports programed activities between the City Government of Ormoc, the Department of Education, Culture and Sports (DECS) and all private sectors; and to totally implement the different sports activities in Ormoc City;

RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable City Mayor and the Division Superintendent of Schools, Ormoc City Division, DECS, Ormoc City;


