

RESOLUTION NO. 108

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE SENATOR HEHERSON T. ALVAREZ TO FACILITATE A REDUEST OF THE 5TH SANGGUNIANG PANLUNGSOD NG ORMOC FOR A COPY OF A SPOT SATELLITE IMAGERY OR AERIAL PHOTOGRAPH OF THE FOREST COVER OF LEYTE PROVINCE, MOST PARTICULARLY AREAS WITHIN THE TERRITORIAL JURISDICTION OF ORMOC CITY.

WHEREAS, the most nagging problem of the City of Ormoc is the dwindling forest cover of its watersheds, most specifically the areas covered by the PNOC reservation;

the ecology of Ormoc City's forests may have been gravely WHEREAS the ecology of Grand Lity s to establish to slight rainy tell by illegal cutting of standing trees because on slight rainy affected by spells the rivers of Ormoc City immediately floods with heavy siltation, a sure sign of soil erosion caused by barren hillsides which never happened before when Ormoc City's forest cover was still intact;

WHEREAS, Brmoc City's water system supply is also noticeably waning evidences by a critical shortage of spring-fed water systems which are now reinforced by deep-well artesian wells, which, of course, also depends on the existence of a good watershed;

WHEREAS, this august Body is practically in the dark apropos the real situation of the forest cover as there is no real and factual ecord of such forest cover;

WHEREAS, to aid in legislation, this august Body needs a true statistic and if possible a pictorial portrayal of the true situation of our forest cover;

NOW, THEREFORE, on motion of Kagawad Romeo M. Hermosilla, severally seconded by Mga Kagawad Eufrocino C. Codilla, Jr., Gregorio A. Yrastorza, Jr., and Antero T. Fiel; be it

Alvarez, Chairman, Committee on Natural Resources and Ecology of the Senate, to solicit or intercede for the help of Administrator Jose Solis, of the National Mapping and Resource Information Authority (NAMRIA) to furnish the 5th Sangguniang Panlungsod ng Ormoc with a copy of a satellite imagery or aerial photogrammetric picture of the forest cover of the portion of Leyte, most specifically the area covered by the PNOC reservation and the area under the territorial jurisdiction of Ormoc
