

RESOLUTION NO. 11

A RESOLUTION AUTHORIZING THE CITY TREASURER TO PAY THE CLAIMS OF THE CITY TELEPHONE COMPANY FOR TELEPHONE CHARGES/RENTAL OF SOME CITY GOVERNMENT OFFICES AND IN RESIDENCES OF SOME CITY OFFICIALS ON THE BASIS OF THE NEW MINIMUM CHARGES FOR AN OUTSIDE BASE RATE AREA.

"WHEREAS; this augst Body is in receipt of a communication of the City Treasurer informing, among others, that his office has received from the Ormoc City Telephone Company claim vouchers for telephone charges/rental of some city government offices and in residences of some city officials;

WHEREAS, the City Treasurer's upon careful perusal of said vouchers revealed that the company has charged an outside base rate of P14.00 per kilometer in addition to the subscription rate per month for telephone connections beyond the established base line of the city proper:

"WHEREAS, the Office of the City Treasurer has held pending the processing of said vouchers until such time this august Body will pass a resolution authorizing him to pay the claims on the basis of the new charges;

"NOW, THEREFORE, on motion of Kagawad Eufrocino C. Codilla, Jr., seconded by Kagawad Arnulfo C. Salazar; be it

"RESOLVED, to authorize the City Treasurer to pay the claims of the City Telephone Company for telephone charges/rental of some city government offices and in residences of some city officials on the basis of the new minimum charges for an outside base rate area;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable City Mayor, the City Treasurer, the City Budget Officer, and the Ormoc City Telephone Company, all in Ormoc City;

"CARRIED UNANIMOUSLY."
