A RESOLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE AMOUNT OF THIRTY SEVEN THOUSAND THREE HUNDRED THIRTY FIVE PESOS & 90/100 (P37,335.90) IN FAVOR OF SAN ANTONIO COMMUNITY SCHOOL REPRESENTING THE INDEMNITY RECEIVED BY THE CITY FROM THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS IN PAYMENT OF THE DAMAGES OF THE SCHOOL PROPERTY OF BARANGAY SAN ANTONIO MADE BY THE HANIL CONSTRUCTION IN WIDENING THE ORMOC-ALBUERA ROAD AND THIS AMOUNT BE GIVEN FOR EXPENDITURE PURPOSES ONLY NOT TO BE RELEASED IN TOTO.

RESOLVED, to authorize the City Treasurer to release the amount of THIRTY SEVEN THOUSAND THREE HUNDRED THIRTY FIVE PESOS & 90/100 (P37,335.90) in favor of San Antonio Community School representing the indemnity received by the city from the Department of Public Works and Highways in payment of damages of the property of said school made by the Hanil Construction in widening the Ormoc-Albuera road and this amount be given for expenditure purposes only not to be released in toto;


