A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN TO DONATE TO THE DEPARTMENT OF EDUCATION, CULTURE AND SPORTS (DECS) LOT NO. 8411 OF THE CADASTRAL SURVEY OR ORMOC, REGISTERED IN THE NAME OF THE PITY GOVERNMENT OF ORMOC COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 801 FOR THE CONSTRUCTION OF VALENCIA BARANGAY HIGH SCHOOL DEVELOPMENT PLAN.

WHEREAS, this august Body is in receipt of a communication dated October 17, 1988 of Mr. Eliseo P. Polido, Teacher-In-Charge, Valencia Barangay High School, requesting donation of the lot where the Valencia Barangay High School is located, considering that there is now a pressing need to establish its location status as it is now a duly recognized autonomous high school - among the other duly recognized barangay high schools in Ormoc City;

WHEREAS, on Oct. 8, 1988 the Barangay Council of Valencia enacted Resolution No. 3, earnestly requesting, among others, the City Government of Ormoc, through this august Body the absolute donation of a lot presently the site of Valencia Barangay High School to the Department of Education, Culture and Sports (DECS) to serve as site of additional school building for the said school;

WHEREAS, Barangay Valencia has received a communication from the Department of Education, Culture and Sports (DECS) that there is now an appropriation in the amount of more than P2M for the construction of three (3) kinds of building namely: Library and Administration Office; Home Management and Technology Building; and a two-storey Academic Building to be constructed on the lot donated from the city government of Ormoc to the DECS;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, severally seconded by Mga Kagawad Rodolfo L. Rivilla, Jr., Antero T. Fiel, and Romeo M. Hermosilla; be it
