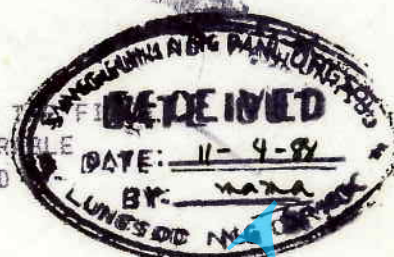
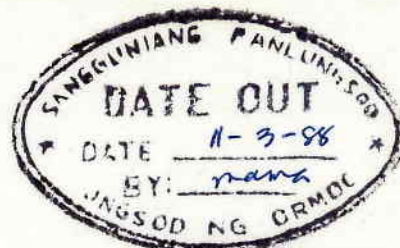

RESOLUTION NO. 115

A RESOLUTION ADOPTING RESOLUTION NO. 418, SERIES OF 1988 OF THE SANGGUNIANG PANLUNGSOD OF BACOLOD, RECOMMENDING TO THE CONGRESS OF THE PHILIPPINES THROUGH THE SENATE AND HOUSE OF REPRESENTATIVES TO ENACT A LAW ALLOCATING TO THE LOCAL GOVERNMENT UNIT WHERE THE OFFICE OF THE REGISTER OF DEEDS IS LOCATED NO LESS THAN THIRTY PERCENT (30%) OF THE TOTAL REVENUES AND OTHER FEES COLLECTED BY SAID OFFICE FROM REGISTRATIONS AND OTHER TRANSACTIONS AFFECTING LANDS LOCATED WITHIN SAID LOCAL GOVERNMENT UNIT.

WHEREAS, this august Body is in receipt of Resolution No. 418, Series of 1988 of the Sangguniang Panlungsod of Bacolod, recommending to the Congress of the Philippines through the Senate and House of Representatives to enact a law allocating to the local government unit where the Office of the Register of Deeds is located no less than thirty percent (30%) of the total revenues and other fees collected by said office from registrations and other transactions affecting lands located within said local government unit;

WHEREAS, the Fifth Sangguniang Panlungsod ng Ormoc conforms and concurs to said resolution of the Sangguniang Panlungsod of Bacolod;


