RESOLUTION NO. 119

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN TO RECEIVE THE DONATION OF NINE (9) UNITS OF STREETLIGHTING FACILITIES INSTALLED AT BARANGAY CAN-UNTOG, ORMOC CITY, AND NOTIFYING THE CITY TREASURER TO PAY THE POWER BILLS PROVIDED IT DOES NOT EXCEED 250 WATTS.

WHEREAS, the Barangay Council of Can-untog, this city has furnished this august Body its Resolution No. 2, Series of 1988 signifying intention to donate to the city government of Ormoc through the Fifth Sangguniang Panlungsod ng Ormoc nine (9) units of streetlighting facilities installed at Barangay Can-untog, Ormoc City;

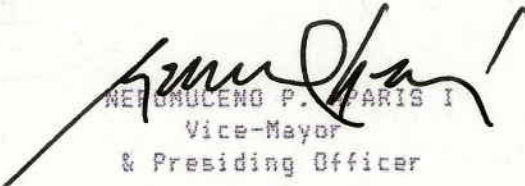

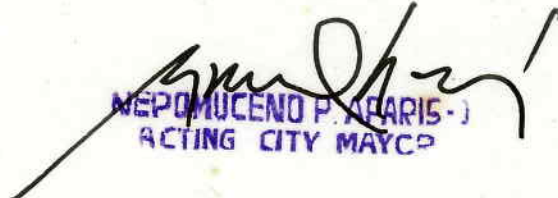
