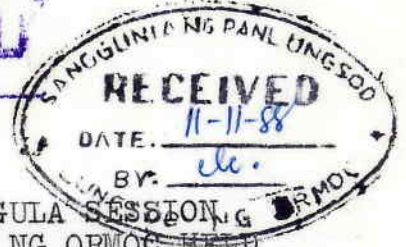

RESOLUTION NO. 121

A RESOLUTION GRANTING THE REQUEST OF THE PROPRIETOR, NADONGHOLAN COCKPIT TO HOLD A THREE-DAY "PINTAKASI" ON DECEMBER 15, 16, and 17, 1988 FOR THE PURPOSE OF RAISING FUNDS TO DEFRAY EXPENSES FOR THE DELEGATES OF THE ORMOC CITY WEST DISTRICT SCOUTING COMMITTEE TO THE BOY SCOUTS REGIONAL JAMBOREE TO BE HELD SOMETIME ON DECEMBER, 1988 AT CEBU CITY, PHILIPPINES.

WHEREAS, on October 22, 1988, on behalf of the Committee, Mr. Pelagio T. Brazil, Jr., Chairman, Ormoc City West District Scouting Committee, communicated with the proprietor of Nadongholan Cockpit, this City, requesting that it be allowed to sponsor a three (3) day "Pintakasi" to be held on December 15, 16, and 17, 1988 at the said cockpit for purposes of raising additional funds to defray expenses for its delegates to the forthcoming Boy Scouts Regional Jamboree to be held sometime on December, 1988, at Cebu City;

WHEREAS, on October 24, 1988, Mr. Claudio P. Larrazabal, Proprietor of Nadongholan Cockpit, acting on said communication request and finding it to be well-founded, in turn, made a communication addressed to the Honorable Members of this August Body, through the Honorable Mayor, Ma.
