WHEREAS, we have been deeply shocked over the sudden and untimely death of a dearly loved and highly esteemed Ex-Vice-Mayor and Acting City Mayor Jose C. Aviles, who succumbed in the afternoon last October 24, 1988;

WHEREAS, the late Engineer Jose C. Aviles, Peping, as he was fondly called by everybody in Ormoc, had greatly helped bring Ormoc to its present status of a financially stable, peaceful and beautiful city. It was not only his inseparable link with the also departed Ex-Mayor Inaki A. Larrazabal, but also his dedication, vision and commitment to his job that brought about a lot of bounty and progress to our beloved city. It is without doubt that Peping had carved an inviable niche in the history of Ormoc City setting up a high yardstick for any future Vice-Mayor to measure his own achievements;

WHEREAS, reckoning back to his service in the government, he was first elected City Councilor of the Municipal Board of Ormoc City from January 1, 1968 to December 31, 1975; reelected Kagawad of the Sangguniang Panlungsod ng Ormoc, January 1, 1976 to January 3, 1980; appointed Acting City Administrator from March 1, 1976 to January 3, 1980; became a Member of the Batasang Bayan, Manila, from 1976 to 1978; elected Vice-Mayor from March 3, 1980 to December 10, 1984; and lastly appointed Acting City Mayor from December 11, 1984 to May 15, 1986;

WHEREAS, we gravely feel the irreparable loss of a conscientious and peace loving Vice-Mayor and Acting Mayor Jose C. Aviles, whose outstanding records of public service bear witness to these achievements for the benefit and welfare of the people of Ormoc in particular and for the real progress and prosperity of Ormoc City in general;

RESOLVED, FURTHER, to affix our signatures on this resolution of condolence, and be it;


