RESOLUTION NO. 128

A RESOLUTION EARNESTLY REQUESTING THE REGIONAL DIRECTORS OF THE BUREAUS OF COMMERCE & INDUSTRY AND HEALTH, BOTH OF TACLOBAN CITY, TO CONDUCT A THOROUGH SURVEY OF ALL BUSINESS ESTABLISHMENTS IN ORmoc CITY AND CHECK ITEMS OF DRUGS SOLD TO THE CONSUMING PUBLIC FOR LAPSE OF DATES OF EXPIRATION, DEFECTIVE CANS, SALE OF NUCLEAR RADIATED FOOD ITEMS AND THE STRICT IMPLEMENTATION OF THE PRICE TAG LAW.

WHEREAS, numerous complaints have been aired from the Consumers Association, as well as the consuming public regarding items sold in the different stores in Ormoc City where there are several goods being sold with the date of expiry already lapsed;

WHEREAS, some businessmen are selling canned food items with dented cans which are unsafe to the consumers;

WHEREAS, to minimize or eradicate these mal-practices of selling these kind of items of drugs and goods sold with date of expiry already lapsed, thorough survey of business establishments must be done and the Price Tag Law be strictly implemented;

NOW, THEREFORE, on motion of Kagawad Romeo M. Hermosilla, seconded by Kagawad Gregorio A. Yrastorza, Jr.; be it

RESOLVED, to earnestly request the Regional Directors of the Bureaus of Commerce & Industry and Health, both of Tacloban City, to conduct a thorough survey of all business establishments in Ormoc City and check items of drugs sold to the consuming public for lapse of dates of expiration, defective cans, sale of nuclear radiated food items and to strictly implement the Price Tag Law;
