## RESOLUTION NO.

A RESOLUTION AUTHORIZING THE HOW. CITY MAYOR MA. VICTORIA L. LOCSIN TO DONATE TO THE DEPARTMENT OF EDUCATION, CULTURE & SPORTS (DECS) AND TO SIGN THE DEED OF DONATION, IN BEHALF OF THE CITY GOVERNMENT OF ORMOC THEREOF, THE AREA DESIGNATED AS PLAIA AND A PORTION OF THE ROAD AT THE SIDE OF THE PLAIA AT BRGY. ALTA VISTA, CONTAINING AN AREA OF 7.400 SO METERS, MORE OR LESS, COVERED BY TRANSFER CERTIFICATE OF TITLE WO. 14204, PROVIDED; THAT, IF SAID LOT IS NO LONGER USED FOR SAID PURPOSE OR NOT BE ACCEPTED BECAUSE IT IS TOO SMALL, THE SAME SHALL BE REVERTED TO THE CITY GOVERNMENT OF ORMOC.

MEREAS, the Barangay Council of Alta Vista in its Resolution No. Series of 1988, has requested the Monorable Members of the 5th ngguniang Panlungsod ng Branc to denate to the Department of tation, Culture and Sports (DECS), the area designated as plaza and a room school bailding;

THEREFORE, on motion of Kagawad Antero T. Fiel, unanimously NOW. seconded; be it

RESOLVED, to authorize the Hon. City Mayor Ma. Victoria L. Locsin to donate to the Department of Education, Culture and Sports (DECS) and to sign the Deed of Donation, in behalf of the City Sovernment of Grmoc thereof, the area designated as plaza and a portion of the road at the side of the plaza at Brgy. Alta Vista, containing an area of 7,400 sq. meters, more or less covered by Transfer Certificate of Title No. 16204, Provided; that, if said lot is no longer used for said purpose or not be accepted because it is too small, the same shall be reverted to the City Government of Grmoc;
