RESOLUTION NO. 130

A RESOLUTION AUTHORIZING THE CITY TREASURER TO PAY THE SALARY/BONUS OF THE OFFICER-IN-CHARGE, CITY ASSESSOR'S OFFICE, ORNOC CITY, FROM THE UNUSED APPROPRIATED SALARY OF THE CITY ASSESSOR AT THE RATE HE IS ACTUALLY RECEIVING AS A PROVINCIAL ASSESSOR.

WHEREAS, Mr. Briceia Supress, Provincial Assessor, Officer-In-Charge City Assessor's Office, in his letter-request dated October 27, 1988 has requested that he be paid his salary from the funds of the city government of Ormoc, pursuant to Section 7.6.4 of the Local Administrative Regulations No. 1-85 dated February 7, 1985 and likewise to pay the year) boxus as provided for under Section 7.6.7 of same regulations;

WMEREAS: "Section 7.5.4 of the Local Administrative Regulations No.

Assessment Office shall, for a period of ninety (90) days, continue to receive his salary from his regular station. After the lapse of ninety (90) days, he shall be paid by the province, city or municipality where he is stationed at the rate that he is authorized to receive in his regular station;

WHEREAS, Section 7.6.7 of same regulations also, states:

Such Officers-in-Charge shall likewise be entitled to collect cost-of-living allowances, bonus, hazard pay and other esoluments that may be authorized by their new stations;

WHEREAS, the City Treasurer regarding the matter opined that he is amenable provided that a resolution is in order authorizing him to do so

as provided for in Sections 7.6.4 and 7.6.7 of the Local Administrative Regulations No. 1-85 dated February 7, 1985;

WHEREAS, this august Body believes that the request is reasonable and forthwith be given due course and favorable consideration;

MBW, THEREFORE, on motion of Kagawad Sixto T. Pongos, severally seconded by Mga Kagawad Eufrocino C. Codilla, Jr., Celso P. Adolfo and Celso P. Porcadilla; be it

RESOLVED, to authorize the City Treasurer to pay the salary/benus of the Officer-in-Charge, City Assessors' Office, Granc City, from the unused appropriated salary of the City Assessor at the rate he is actually receiving as a Provincial Assessor;

Honor, the City Mayor; the Office-in-Charge, the City Assessor's Office; the City Budget Officer; and the City Treasurer, all in Ormoc City.
