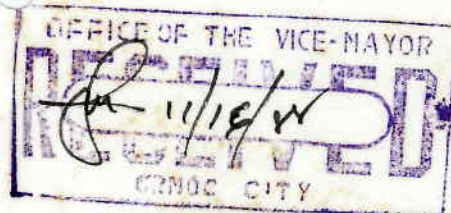
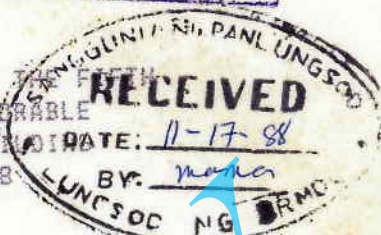

RESOLUTION NO. 133

A RESOLUTION EARNESTLY REQUESTING HER EXCELLENCY PRESIDENT CORAZON C. AQUINO THAT THE RELEASES OF CALAMITY FUNDS INTENDED FOR REGION VIII BE RELEASED SOONEST BECAUSE ORMOC CITY IS SUFFERING FROM DAMAGES WROUGHT BY TYPHOON "UNSAANG".

WHEREAS, last October 6-7, 1988 typhoon "Unsaang" wrought havoc and massive damages to government infrastructure, agricultural crops and loss of houses and lives;

WHEREAS, the aftermath of said typhoon, Ormoc City alone suffered damages according to assessment report by the City Engineer amounted to P7.5 Million more or less;

WHEREAS, recently Her Excellency President Corazon C. Aquino ordered the releases of calamity funds to places declared calamity areas, of which Ormoc City is a part of Region VIII;

WHEREAS, a resolution is in order to hasten the releases of this calamity funds for the immediate restoration of the damages wrought by the super typhoon "Unsaang".

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, unanimously seconded; be it

RESOLVED, to earnestly request Her Excellency President Corazon C. Aquino that the releases of funds intended for Region VIII, including Ormoc City be made soonest to alleviate the suffering people of Ormoc, to repair farm to market roads; public buildings and relief to the people who are most needy;

RESOLVED, FURTHER, to effect this resolution by way of telegram to Her Excellency President Corazon C. Aquino for her immediate information and approval.


