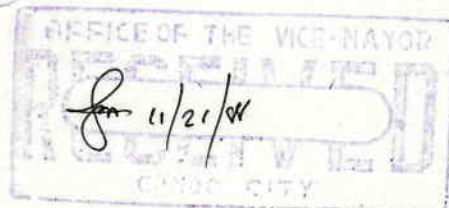

RESOLUTION NO. 136

A RESOLUTION EARNESTLY REQUESTING HER EXCELLENCY PRESIDENT CORAZON C. AQUINO FOR THE IMMEDIATE RELEASE OF ORMOC CITY'S CALAMITY FUND FOR THE VICTIMS AND DAMAGES WROUGHT TO THIS CITY BY TYPHOON "YONING".

WHEREAS, after typhoon "Unsang" which occurred last October 23-24, 1988, another super typhoon came in named "Yoning" which occurred last Nov. 6-7, 1988, brought havoc and massive damages both to governmental structures, roads and bridges, and even loss of houses and lives;

WHEREAS, Her Excellency President Corazon C. Aquino ordered releases of calamity funds intended for affected areas of which Region VIII, including Ormoc City is a recipient of such funds;

WHEREAS, to facilitate the release of Ormoc City's calamity funds it is imperative to respectfully request Her Excellency President Corazon C. Aquino for the immediate release of said funds;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, unanimously seconded; be it


