

WHEREAS, after typhoon "Unsang" which occured last October 23-24, 1988, another super typhoon came in named "Yoning" which occured last Nov. 6-7, 1988, brought havec and massive damages both to governmental structures, roads and bridges, and even loss of houses and lives;

WHEREAS, Her Excellency President Corezon C. Aquino ordered releases of calamity funds intended for affected areas of which Region VIII, including Grase City is a recipient of such funds;

WHEREAS, to facilitate the release of Ormoc City's calamity funds it is imperative to respectfully request Her Excellency President Corazon C. Aquino for the immediate release of said funds;
