COMMITTEE ON TRANSPORTATION & COMMUNICATION - matters relating to the
proper administration and control of transportation facilities,
such as; public utility vehicles, shipping vessels, aircrafts, and
the like, and also, matters relating to the administration of
various communication facilities and services;

COMMITTEE ON YOUTH DEVELOPMENT - matters relating in the upliftment of
the youth in their moral, physical, and intellectual well-being
and development.

COMMITTEE ON TRADE AND COMMERCE - matters relating to commercial
transactions and the marketing of products and merchandise.

COMMITTEE ON CITIES SISTERHOOD PROGRAM - matters relating to establishing a tie-up with sister cities and promoting an exchange program in public administration, culture and socio-economic activities.


