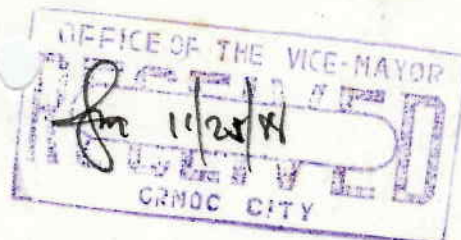

A RESOLUTION GRANTING VALENCIA SPORTS CENTER TO HOLD A THREE-DAY

UPDATED REPORT OF THE FUND RAISING CAMPAIGN FOR THE INFORMATION OF
THE MEMBERS OF THE FIFTH SANGGUNIANG PANLUNGSOD NG ORMOC.

WHEREAS, in a letter dated November 11, 1988, Mr. Pelagio T.
