## RESOLUTION NO. 141

A RESOLUTION REQUESTING THE OFFICER-IN-CHARGE OF LEYECO V ESPECIALLY MAINTENANCE TO EXPEDITE REPAIR OF ELECTRIC WIRINGS CONNECTIONS AT BARANGAY PUNTA, ORMOC CLTY, DUE TO ITS FAST APPROACHING BARANGAY FIESTA ON DÉCEMBER 3, 1988:

WHEREAS, the Barangay Captain of Barangay Punta, Grmoc City, has the all out plan and intention of promoting program of activities in their barangay relative to their fast approaching Barangay Fiesta on December 3, 1988;

WHEREAS, the aforesaid plan and intention can downright be obstructed due to electric power failure in said barangay, as one aftermeth of typhoon "Yoning" which devastatingly hit Ormoc City;

WHEREAS, this problem on electric power failure and request for the immediate solution thereof is addressed to the Management, LEYECO V, Ormoc City, the same communication also being coursed through the Monorable Sangguniang Panlungsod of Ormoc and, for this august Body to intercede in behalf of Barangay Punta to earnestly request the Management of LEYECO V to immediately expedite the repair of electric wirings or connections in said barangay, so as to provide the barrio with light and, too, to materialize their plan and preparation of the different activies for their fast-coming Barangay Fiesta on December 3, 1988;
