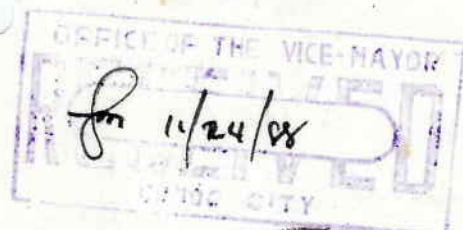

RESOLUTION NO. 142

A RESOLUTION REQUESTING AUTHORIZATION FROM THE DEPARTMENT OF LOCAL GOVERNMENT (DLG) TO AUTHORIZE THE HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN TO UTILIZE THE AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF) FOR ORGANIZATIONAL AND TRAINING EXPENSES OF THE CIVILIAN VOLUNTEERS ORGANIZATION (CVO) OR BANTAY BAYAN FORCE.

WHEREAS, the Vice-Mayor and Acting City Mayor (vice Her Honor, the City Mayor who is on leave), apropos viability and importance of organizing the Civilian Volunteers Organization or Bantay Bayan Force, which carries with it the amount of Fifty Thousand Pesos (P50,000.00) to cover training expenses of around fifty (50) persons to compose the core group;

WHEREAS, the resurgence of criminality specially in the rural areas has been attributed to lack of support and limited knowledge of the rural folks regarding the activities of insurgents in our locality;

WHEREAS, upon consultation with the military, they are amenable to organize the Civilian Volunteers Organization so as to maintain peace and order situation in the city;

NOW, THEREFORE, on motion of Kagawad Rodolfo L. Rivilla, Jr., seconded by Kagawad Gregorio A. Yrastorza, Jr.; be it


RESOLVED, to request authorization from the Department of Local Government (DLG) to authorize the Honorable City Mayor Ma. Victoria L. Locsin to utilize the amount of Fifty Thousand Pesos (P50,000.00) from out of the 20% Economic Development Fund (EDF) to cover organizational and training expenses of around fifty (50) persons to compose the core group of the Civilian Volunteers Organization (CVO) or Bantay Bayan Force in Ormoc City;


