RESOLUTION NO. 145

A RESOLUTION ADOPTING IN TOTO THE REASONS GIVEN BY THE SANGGUNIANG PANLALAWIGAN OF BUKIDNON IN SUPPORT OF THIS AUGUST BODY'S OPPOSITION OR REACTION TO THE PASSAGE OF HOUSE BILL NO. 9475.

WHEREAS, this august Body is in receipt of Resolution No. 88-827, Series of 1988, of the Sangguniang Panlalawigan of Bukidnon, submitting to the Committee on People's Power and Participation, House of Representatives, the reactions of the Honorable Sangguniang Panlalawigan of Bukidnon to House Bill No. 9475;

WHEREAS, House Bill No. 9475 is about the "institutionalization of people power in the local government legislative bodies by requiring such bodies to include in the order of business of all regular sessions, a mandatory time to be known as "People Hour or Oras ng Bayan", in which during this time concerned citizen is given the privilege to express his legitimate grievances against the government; denounce public officials or public servants for their malfeasance and misfeasance and to make constructive criticism or suggestions that will enhance the efficiency of public service;"

WHEREAS, the Fifth Sangguniang Panlungsod ng Ormoc is in accord with the reaction of the Sangguniang Panlalawigan of Bukidnon, which in effect, opposes the passage of House Bill No. 9475 because as stated in Resolution No. 88-827 there are already enough agencies or mechanisms provided for by the government to help and attend to the people's grievances;

WHEREAS, this august Body concurs the embodiment of said resolution of the Sangguniang Panlalawigan of Bukidnon;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, severally seconded by Mga Kagawad Eufrocino C. Codilla, Jr., Armulfo C. Salazar and Celso P. Porcadilla; be it


