RESOLUTION NO. 149

A RESOLUTION URGENTLY REQUESTING THE HON. CARMELO J. LOCSIN,
REPRESENTATIVE 4TH DISTRICT OF LEYTE TO SPONSOR A BILL IN
CONGRESS TO DONATE THE LOT PRESENTLY OCCUPIED BY THE ORMOC
CITY HIGH SCHOOL TO THE DEPARTMENT OF EDUCATION, CULTURE,
AND SPORTS (DECS).

WHEREAS, we will recall that during the term of Congressman Domi-
nador M. Tan, he sponsored a bill in Congress for the purchase of a
private lot which was supposed to be utilized as the lot in which the
Ormoc City High School is to be built;

WHEREAS, as the years pass by this lot which was acquired from
the private sector was titled in the name of the Republic of the Philip-
pines;

WHEREAS, the present administration of the Ormoc City High School
has envisioned additional building and other structures in which to be
constructed in said lot and according to the DECS that funds are ready
and be made available for this purpose but it could not be released
because it is not yet owned by the DECS but instead by the Republic of
the Philippines;

WHEREAS, the local government of Ormoc being a separate municipal
corporation from the Republic of the Philippines cannot donate the
property to the DECS;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, jointly
seconded by Mga Kagawad Antero T. Fiel and Celso P. Porcadilla; be it

RESOLVED, to urgently request the Hon. Carmelo J. Locsin, Representative, 4th District of Leyte to donate the lot presently occupied by the Ormoc City High School to the Department of Education, Culture and Sports (DECS) for the construction of additional building and other structures;


RESOLVED, FURTHER, to furnish a copy of this resolution each to Hon. Congressman Carmelo J. Locsin, 4th District of Leyte, Congress of the Philippines, Manila; Her Honor, the City Mayor; the Division Superintendent of Schools, and the Secondary School Principal, OCHS, all in Ormoc City;
