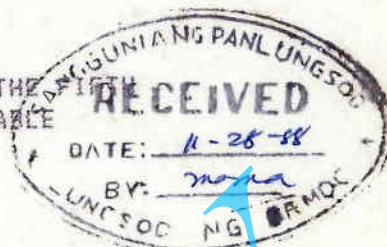

RESOLUTION NO. 150

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN, IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, TO ENTER INTO A CONTRACT OF AGREEMENT WITH THE YAKAL CONSTRUCTION FOR THE LATTER TO UNDERTAKE THE CONSTRUCTION OF THE 2ND STOREY OF THE ORMOC CITY JAIL AT A CONTRACT PRICE OF THREE HUNDRED SIXTY TWO THOUSAND PESOS (P362,000.00).

WHEREAS, there is now being prepared a Contract of Agreement to be entered into by the Honorable City Mayor Ma. Victoria L. Locsin, in behalf of the City Government of Ormoc with the Yakal Construction for the latter to undertake the construction of 2nd Storey of the Ormoc City Jail at a contract price of THREE HUNDRED SIXTY TWO THOUSAND PESOS (P362,000.00);

WHEREAS, corollary to it, the Honorable City Mayor Ma. Victoria L. Locsin, in her communication dated November 24, 1988 has requested for a passage of a resolution authorizing her for and in behalf of the city government of Ormoc, to enter into a Contract of Agreement with the Yakal Construction for the latter to undertake the construction of the same with same contract price;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza Jr., jointly seconded by Mga Kagawad Arnulfo C. Salazar and Rodolfo L. Rivilla, Jr.; be it


