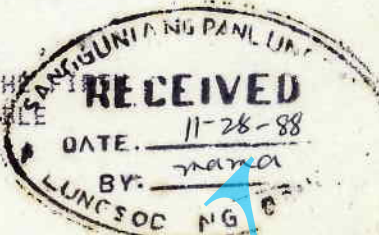

RESOLUTION NO. 151

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN, IN BEHALF OF THE CITY GOVERNMENT OF ORMOG, TO ENTER INTO A CONTRACT OF AGREEMENT WITH THE JSV CONSTRUCTION FOR THE LATTER TO UNDERTAKE THE CONSTRUCTION OF THE COLD HOLD STORAGE AT THE PUBLIC MARKET AT A CONTRACT PRICE OF TWO HUNDRED FORTY ONE THOUSAND TWO HUNDRED FORTY ONE PESOS & 41/100 (P241,241.41), SUBJECT, HOWEVER, TO SUCH TERMS AND CONDITIONS THAT MAYBE FEASIBLE UNDER THE CIRCUMSTANCES.

WHEREAS, there is now being prepared a Contract of Agreement to be entered into by the Honorable City Mayor, Ma. Victoria L. Locsin, in behalf of the City Government of Ormoc, with the JSV Construction for the latter to undertake the construction of the Cold Hold Storage at the public market carrying a contract price of TWO HUNDRED FORTY ONE THOUSAND TWO HUNDRED FORTY ONE PESOS & 41/100 (P241,241.41);

WHEREAS, corollary to it, the Honorable City Mayor Ma. Victoria L. Locsin, in her communication dated November 24, 1988 has requested for a passage of a resolution authorizing her, for and in behalf of the city government of Ormoc, to enter into a Contract with the JSV Construction for the latter to undertake the construction of the same with the same contract price;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., jointly seconded by Mga Kagawad Benjamin F. Tugonon and Rodolfo L. Rivilla, Jr.; be it

RESOLVED, to authorize the Honorable City Mayor Ma. Victoria L. Locsin, in behalf of the city government, to enter into a Contract of Agreement with JSV Construction for the latter to undertake the construction of the Cold Hold Storage at the public market at a contract price of TWO HUNDRED FORTY ONE THOUSAND TWO HUNDRED FORTY ONE PESOS &

41/100 (P241,214.41), subject, however, to such terms and conditions that maybe feasible under the circumstances;
