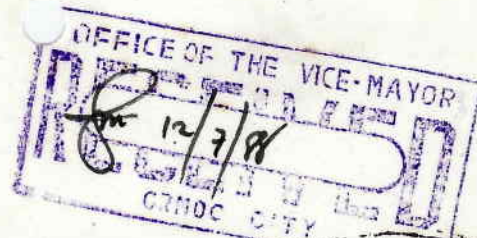

RESOLUTION NO. 152

A RESOLUTION REQUESTING THE OFFICE OF THE PRESIDENT FOR AUTHORITY TO
AUTHORIZE THE CITY MAYOR TO GIVE ADDITIONAL CASH GIFT OF ₱500.00
EACH TO THE OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT OF
ORMOC FOR CALENDAR YEAR 1988.

WHEREAS, it is the wish and intention of Her Honor, the City Mayor,
Honorable Ma. Victoria L. Locsin and the Honorable Members of the Sangguniang
Panlungsod of Ormoc City to grant additional cash gift of ₱500.00 each to the
officials and employees of the Local Government of Ormoc, in addition to the
one-month-year-end bonus and the ₱1,000.00 cash gift for calendar year 1988;

WHEREAS, the City Budget Officer and the City Treasurer of this city
have given their assurance on the availability of funds for the aforesaid
purpose;

WHEREAS, a very substantial number of the employees of the Local Govern-
ment in Ormoc City were also greatly affected and did incur damages of their
houses and other properties as aftermath of the two devastating typhoons,
"Unsang" and "Yoning" which hit Ormoc, among other places, on October 24
and November 7, 1988, respectively;

WHEREAS, in order to grant this additional cash gift of ₱500.00, which
is in excess of what is allowed under existing laws, there being a need to
request for an authority from the Office of the President;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, duly seconded by
Mga Kagawad Arnulfo C. Salazar, Celso P. Porcadilla and Benjamin F. Tugonon;

ippines for authority to authorize the City Mayor of Ormoc City to give
additional cash gift of ₱500.00 each to the officials and employees of the
Local Government of Ormoc for the calendar year 1988;
