

RESOLUTION NO. 21

A RESOLUTION EARNESTLY AND URGENTLY REQUESTING ALL THE DEPARTMENT HEADS AND HEADS OF OFFICES OF THE CITY GOVERNMENT OF ORNOC TO PLEASE SUBMIT TO THE SANGGUNIANG PANLUNGSOD THROUGH THE PRESIDING OFFICER OR THROUGH THE SECRETARIAT AN INVENTORY OF ALL CITY GOVERNMENT OWNED MOTOR VEHICLES ASSIGNED TO THEIR OFFICES, WITH THEIR CORRESPONDING DESCRIPTION WHETHER THEY ARE IN RUNNING CONDITION OR ALREADY IN THE JUNK YARD, AND AS REGARDS THE ENGINEERING DEPARTMENT IS CONCERNED TO INCLUDE HEAVY EQUIPMENT.

"WHEREAS, every start of calendar year, this Body prepares and approves the annual appropriation law (Annual Budget) for the city government, incorporating therein various appropriations, for maintenance of motor vehicles, repairs and servicing, spare parts, gasoline and oil;

"WHEREAS, it is indeed lamentable that presently, this Body, is not very much knowledgeable insofar as the number of motor vehicles owned by the City Government of Ormoc;

"WHEREAS, for the proper guidance, information and as an aid to whatever legislation this Body may enact in the future, relative to such city owned government vehicles, it is imperative, that an inventory of such vehicles be made and submitted to this Body;

"NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, jointly seconded by Mga Kagawad Gregorio A. Yrastorza, Jr., and Arnulfo C. Salazar; be it

"RESOLVED, to earnestly and urgently request all the department heads, and heads of offices of the City Government of Ormoc to please submit to the Sangguniang Panlungsod through the Presiding Officer or through the Secretariat an inventory of all motor vehicles assigned to

their respective offices with their corresponding description whether they are in running condition or already in the junk yard, and as regards the City Engineering Department is concerned to include heavy equipments;
