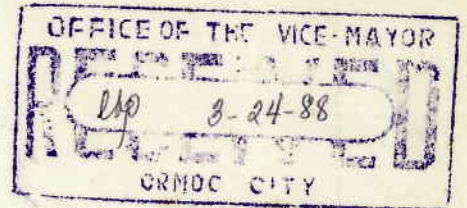

RESOLUTION NO. 22

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ALLOW OPERATION
OF ADDITIONAL THIRTY-FIVE (35) UNITS OF MOTORIZED TRICYCLES FOR
HIRE IN THE CITY OF ORMOC.

"WHEREAS, Kagawad Eufrocino C. Codilla, Jr., in his capacity as
Chairman on Transportation and Communications has requested for an
additional 35 units motorized tricycles for hire to operate within the
City of Ormoc to meet the demands, satisfaction and to alleviate the
problems of the commuters or riding public in the different points of
the City and suburbs;

"WHEREAS, it has been noted that the present number of motorized
tricycles for hire operating in the city could not cope with the needs
of the riding public considering the increase in population in the City
of Ormoc;

"WHEREAS, Barangays near the city, particularly those without
transportation operators, bewail the situation that during night time
and in cases of emergency no transportation facility is available; that
it behooves, therefore, that urban/rural Barangays near the city can
avail of motorized tricycles for hire services;

"NOW, THEREFORE, on motion of Kagawad Eufrocino C. Codilla, Jr.,
severally seconded by Mga Kagawad Gregorio A. Yrastorza, Jr., Arnulfo C.
Salazar; and Rodolfo L. Rivilla, Jr.; be it

"RESOLVED, to authorize the Honorable City Mayor to allow the
operation of additional thirty-five (35) units motorized tricycles for
hire in the City of Ormoc;


