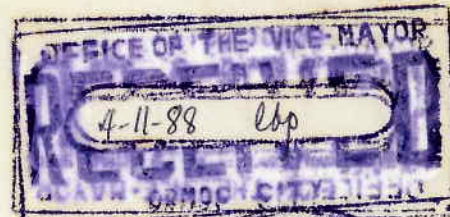

A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE AGAINST
CURRENT APPROPRIATION ON SUPPLIES AND MATERIALS OF THE CITY HEALTH
OFFICE THE SUM OF ONE THOUSAND THREE HUNDRED NINETEEN PESOS &
10/100 (P1,319.10), TO BE MADE AVAILABLE FOR THE PAYMENT OF 30
BOTTLES RUBBING ALCOHOL, 4 DOZENS GLOVES 7 1/2 AND 1 GALLON LYSOL
FOR USE IN THE LABORATORY OF SAID OFFICE.

available for the payment of the following:

- 30 bottles rubbing alcohol;
- 4 dozens gloves - 7 1/2; and
- 1 gallon lysol.
