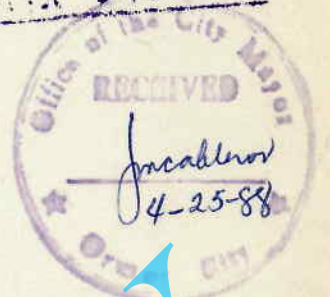
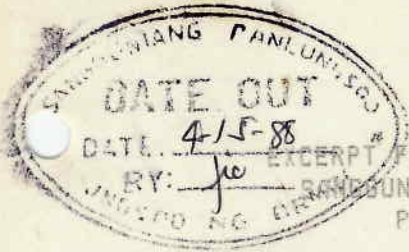
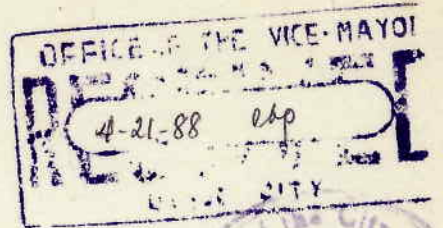

RESOLUTION NO. 28

A RESOLUTION FAVORABLY ENDORSING HOUSE BILL NO. 5665 AND ASKING THE
KIND HELP OF THE HONORABLE CONGRESSMAN OF THE 4TH DISTRICT OF LEYTE
CARMELO LOCSIN IN THE EVENT THE SAME WILL BE DELIBERATED IN THE
HOUSE OF CONGRESS, TO SUPPORT TO IT, WITH THE COMMENT ALSO, THAT
SALARIES OF THE MAYORS AND THE VICE-MAYORS SHOULD BE INCREASED AT
PAR OR EQUAL TO WHAT THE MAYORS AND VICE-MAYORS ARE NOW RECEIVING
OR EVEN HIGHER THAN THEIR PRESENT RATE AND ALSO, THOSE OF THE
SALARIES OF THE SANGGUNIANG PANLUNGSOD.

"WHEREAS, we are in receipt of House Bill No. 5665, for comments,
introduced by the Honorable Congressman of the 2nd District of Davao
Cornelio P. Maskarino, among others, upgrading and standardizing the
monthly basic salaries of the Governors, Vice-Governors, and Members of
the Sangguniang Panlalawigan of Provinces and of the Mayors, Vice-
Mayors, and the Sangguniang Panlungsod Members of Cities and
Municipalities, providing for their funding, and for other purposes;

"WHEREAS, we conform and adhere to the embodiment of said bill
because it libes the recent pronouncements of Her Excellency President
Corazon C. Aquino to rationalize the compensation of all local
officials;

"NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon;
unanimously seconded; be it


"RESOLVED, to favorably endorse Bill No. 5665, and asking the kind
help of the Honorable Congressman Carmelo Locsin in the event House Bill
No. 5665 will be deliberated in the House of Congress, to urgently
support to it with the comment also that salaries of the Mayors and the
Vice-Mayors should be increased at par or equal to what the Mayors and
the Vice-Mayors are now receiving or even higher than their rate and
also those of the salaries of the Sangguniang Panlungsod.


