A RESOLUTION EARNESTLY REQUESTING THE HONORABLE SECRETARY OF LOCAL  
GOVERNMENT FOR THE AVAILMENT OF THE NATIONAL AID TO LOCAL  
GOVERNMENT UNITS (NALGU) FUND FOR THE IMPROVEMENT OF THE MARKET  
COMPLEX OF ORMOC CITY IN THE AMOUNT OF ONE MILLION PESOS (P1M)

"WHEREAS, we are in receipt of the Sr. Local Government Officer,  
Silvestre D. Valencia, DLG City Development Office regarding the  
communication of the Asst. Regional Director, Crispulo R. Truya of the  
Department of Local Government, Region VIII, Tacloban City, inquiring us  
if we still consider the request of the Third Sangguniang Panlungsod ng  
Ormoc Members on its Resolution No. 285, dated October 7, 1987, among  
others, requesting the availment of the National Aid to Local Government  
Units (NALGU) Fund for the improvement of the Market Complex in the  
amount of P1M.;

"WHEREAS, the City Engineer's Office has already prepared a  
Detailed Estimate of the proposed project costing P1,700,000.00;

"WHEREAS, it is the prerogative of this august Body to have  
definitely this proposal be still Ormoc City's priority projects;


