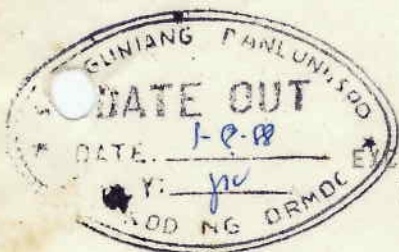

RESOLUTION NO. 333

A RESOLUTION AUTHORIZING THE HONORABLE OIC-CITY MAYOR GUILLERMO T. PARRILLA IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, TO ACCEPT THE DONATION OF BARANGAY MILAGRO OF NINE (9) UNITS FLUORESCENT LIGHTING FIXTURES, 20-WATT, 220-VOLT, COMPLETE WITH WEATHER PROTECTORS, MOUNTING BRACKETS AND LEAD OUT WIRES; TO BE INSTALLED AT STRATEGIC PLACES OF BARANGAY MILAGRO, WITH THE SUPPLICATION THAT THE POWER CONSUMPTION BE BORNE BY THE CITY, SUBJECT, HOWEVER, TO RESOLUTION NO. 1149 DATED APRIL 20, 1982.

"WHEREAS, the Barangay Council of Milagro in its Resolution No. 2, current series, has signified their intention to donate nine (9) units fluorescent lighting fixtures, complete with weather protectors and mounting brackets, 20-watt, 220-volt, complete with lead out wires, to the City Government of Ormoc, said units to be installed at strategic places of Barangay Milagro, with the supplication that the power consumption of said units be borne by the City Government of Ormoc in consonance to pertinent ordinance;

"WHEREAS, in order to forestall the commission of crimes against persons and properties this august Body has favorably agreed to accept said donation in fairness to Barangay constituents;

"NOW, THEREFORE, on motion of Kagawad Romeo M. Hermosilla, seconded by Kagawad Edgardo C. de Loyola; be it

"RESOLVED, to authorize the Honorable OIC-City Mayor Guillermo T. Parrilla, in behalf of the City Government of Ormoc, to accept the donation of Barangay Milagro of nine (9) units fluorescent lighting fixtures, 20-watt, 220-volt, complete with weather protectors, mounting brackets and lead out wires, to be installed at strategic areas of

Barangay Milagro, with the supplication that the power consumption of said units be borne by the City, Subject, However, to Resolution No. 1149 dated April 20, 1982.


