RESOLUTION NO. 336

A RESOLUTION URGENTLY REQUESTING THE BLT REGIONAL OFFICE TO OPEN AN AGENCY OFFICE OR TO AUTHORIZE THEIR OFFICE IN ORMOC CITY TO FACILITATE THE ISSUANCE OF BOT PERMITS TO MOTORCABS (MCH) OPERATORS AND TO OTHER MEANS OF TRANSPORTATION.

"WHEREAS, there are some motorcabs (MCH) operating in the City of Ormoc without police numbers;

"WHEREAS, some Motorcabs Operators having no police numbers of their respective motorcabs for hire are more than willing to have police numbers and to pay the corresponding amount as prescribed;

"WHEREAS, according to the personnel of the BLT Office in Ormoc City BOT permit can be secured only in the BLT Regional Office in Tacloban;

"WHEREAS, in order to serve the paying public better and to avoid inconvenience to said payers and to bring the government closer to the people, this august Body finds it necessary to urgently supplicate the BLT Regional Office to open an Agency Office in Ormoc City to facilitate the issuance of the BOT permits;

"NOW, THEREFORE, on motion of Kagawad Cesar A. Fiel, jointly seconded by Mga Kagawad Bienvenido B. Lagado and Romeo M. Hermosilla; be it


"RESOLVED, to urgently request the BLT Regional Office, Tacloban City to open an Agency Office or to authorize their office in Ormoc City to facilitate the issuance of BOT permits to Motorcabs (MCH) Operators and also to other means of transportation;
