RESOLUTION NO. 337

A RESOLUTION TO IMPLEMENT STRICTLY ORDINANCE ON THE PROHIBITION OF
SELLING OF FISHES, ETC. OUTSIDE THE PUBLIC MARKET AREA.

"WHEREAS, Paragraph 2 of Section 4.1.6.4. Other prohibitions, under Article 6. - Prohibitions, of Tax Ordinance No. 1, otherwise known as the 'Ormoc City Revenue Code of 1977', as amended, states that selling, offering for sale, displaying for sale, outside the public market such as: sea foods, vegetables, fruits, cereals, nuts, meat, poultry, foodstuffs, including cooked goods or articles or merchandise" is prohibited;

"WHEREAS, Section 4.1.8.8. of Article 7. - Special provision provides penalty that upon conviction, be punished by a fine of not less than two hundred pesos (P200.00) nor more than fifteen days not more than two months, or both such fine and imprisonment at the discretion of the court. In case of juridical persons, the president or person in charge of the operation thereof shall be liable for the violation;

"NOW, THEREFORE, on motion of Kagawad Felipe P. Adolfo, Jr., seconded by Kagawad Ram F. Capahi; be it

"RESOLVED, to implement strictly ordinance on the prohibition of selling of fishes, etc. outside the public market area, in pursuant to Paragraph 2 of Section 4.1.6.4. and Section 4.1.8.8. of Articles 6 and 7, respectively of Tax Ordinance No. 1, otherwise known as the 'Ormoc City Revenue Code of 1977', as amended;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable City Mayor; the City Treasurer; the Market Master; the Station Commander; the Sub-station Commander, Police Outpost, Public Market and copies to be posted on the bulletin boards, all in Ormoc City;


