RESOLUTION NO. 37

A RESOLUTION FAVORABLY INDORSING AND SUPPORTING RESOLUTION NO. 272 ASKING THE HONORABLE JOINT COMMISSION ON LOCAL GOVERNMENT PERSONNEL ADMINISTRATION FOR AN AMENDMENT OF SECTION 1, CIRCULAR NO. 31, DATED DECEMBER 10, 1987, AS EMBODIED IN RESOLUTION NO. 272 OF THE SANGGUNIANG PANLUNGSOD OF CEBU.

"WHEREAS, the Sangguniang Panlungsod of Cebu has furnished this august Body its Resolution No. 272, dated March 28, 1988, requesting, among others, the Honorable Joint Commission on Local Sovernment Personnel Administration (JCLGPA) to amend Section 1, Circular No. 31 even as that august Body made a petition by way of Position Paper appealing and asking the Honorable Joint Commission that Section 1 of Circular No. 31, dated December 10, 1987, be amended to read, thus:

'Section 1. Effective upon assumption to office, all the members of the Sanggunian in provinces, cities and municipalities shall receive per diem per session actually attended at rates not exceeding the maximum herein prescribed based on the salary circular of the Joint Commission actually being implemented by the local government concerned. They shall, however, be allowed to receive per diem, notwithstanding their absence or failure to actually attend the session; PROVIDED, However, That such absence or failure is due to official business or activities in their performance of their functions and duties which is duly recognized and sanctioned by the legislative body concerned through an appropriate resolution or by a written authority of the City Mayor'.

THEREFORE, on motion of Kagawad Benjamin F. Tugonon, unanimously seconded; be it

"RESOLVED, to favorably endorse and support Resolution. No. 272 asking the Honorable Joint Commission on Local Government Pesonnel Administration to amend Section 1 of Circular No. 31 as embodied in said (RES. NO. 37)

Resolution No. 272, dated March 28, 1988 of the Sangguniang Panlungsod of Cebu, and do as this Body hereby does conform to said resolution and its Position Paper.

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Joint Commission on Local Government Personnel Administration (JCLGPA), Metro Manila; the Honorable Sangguniang Panlungsod of Cebu, Cebu City, and the Honorable City Mayor, Ormoc City;
