RESOLUTION NO. 41

A RESOLUTION FAVORABLY ENDORSING THE REQUEST OF MR. REGOBERTO GENOBIAGON, CHAIRMAN, EAST DISTRICT SCOUTING COMMITTEE, IPIL, ORMOC CITY, AS CONCURRED IN BY THE PROPRIETOR OF NADONGHOLAN COCKPIT; AND WITH THE FAVORABLE APPROVAL BY THE PHILIPPINE GAMEFOWL COMMISSION, TACLOBAN CITY, TO SPONSOR A 3-DAY PINTAKASI ON JUNE 23, 24 & 25, 1988 IN SAID COCKPIT, FOR PURPOSES OF RAISING FUNDS TO FINANCE THE TRAINING OF THE ACTIVE MEMBERS OF THE BOY SCOUTS IN THEIR DISTRICT THIS SCHOOL YEAR 1988-89, WITH THE CONDITION THAT THIS AUGUST BODY BE FURNISHED A COPY OF THE AUDIT OF THE PROCEEDS THEREOF.

"WHEREAS, on April 29, 1988 Mr. Regoberto Genobiagon, Chairman, East District Scouting Committee, communicated to Mr. Claudio P. Larrazabal, Proprietor, Nadongholan Cockpit, requesting that the East District Scouting Committee be allowed to sponsor a 3-day 'Pintakasi' in said Cockpit, on June 23, 24, & 25, 1988 for purposes of raising funds to finance the training of the active members of the Boy Scouts in their district for this school year 1988-89 to lead them to become good and useful citizens in their community in the years ahead;

"WHEREAS, on May 2, 1988 Mr. Claudio P. Larrazabal, Proprietor, Nadongholan Cockpit, acting on said letter-request, in turn, requested this August Body through the Honorable City Mayor Ma. Victoria L. Loosin, to respectfully grant a permit to the Nadongholan Cockpit to hold said 'Pintakasi' on the dates specified therein;

"NOW, THEREFORE, on motion of Kagawad Rodolfo L. Rivilla, Jr., seconded by Kagawad Gregorio A. Yrastorza, Jr.; be it

"RESOLVED, to favorably endorse the request of Mr. Regoberto Genobiagon, Chairman, East District Scouting Committee, Ipil, Ormoc City, as concurred in by the Proprietor of Nadongholan Cockpit and with the favorable approval by the Philippine Gamefowl Commission, Tacloban


