RESOLUTION NO. 46

A RESOLUTION ADOPTING THE STAND AND/OR OPINION OF THE CITY LEGAL
OFFICER REGARDING THE CLAIM OF MR. CIPRIANO PARAISO THAT THE SAME
IS NOT COMPENSABLE AS NO TENANCY RELATIONSHIP EXISTED BETWEEN THE
CITY GOVERNMENT AND MR. PARAISO.

"WHEREAS, this has reference to the claim of a certain Mr. Cipriano
Paraiso claiming for a disturbance compensation alleging, among others,
that Mr. Paraiso has been working on a certain portion of the lot which
has been expropriated by the city;

"WHEREAS, this august Body, on February 22, 1988 thru its
Secretary referred the same to the City Legal Officer for review,
comment and recommendation;

"WHEREAS, on February 23, 1988, the City Legal Officer by way of
indorsement, in turn, rendered opinion on the matter, which is quoted
verbatim, hereunder, thus:

Respectfully returned to the Sangguniang Panlungsod, thru the
Board Secretary, the 3rd Indorsement, dated Feb. 22, 1988, relative
to the claim of Cipriano P. Paraiso, for disturbance compensation
of his tenanted lot in Brgy. San Isidro, Ormoc City, with the

opinion that there existed no tenancy relationship between the City of Ormoc and Mr. Paraiso. There is no record showing that the City of Ormoc have lands that were tenanted, neither there is any record showing that the City of Ormoc has engaged in farming, hence the claim is misplaced.


