## RESOLUTION NO. 48

A RESOLUTION REQUESTING HER EXCELLENCY PRESIDENT CORAZON C. AQUINO AND THE HONORABLE FRANKLIN M. DRILON IN HIS CAPACITY AS SECRETARY OF THE DEPARTMENT OF LABOR AND EMPLOYMENT FOR THE EARLY RESOLUTION OF THE STRIKE AT THE AZNAR'S EQUATORIAL CASSAVA MILL LOCATED AT MONTEBELLO, KANANGA, LEYTE.

"WHEREAS, this august Body is in receipt of a basic-communication of Mr. Mamerto M. Espina. Sr. dated May 28, 1988, which is quoted hereunder, verbatim, thus:

'Dolores, Grmoc City May 28, 1988

Hon Nepomuceno Aparis Vice-Nayor, Ormoc City Ormoc City

Dear Atty. Aparis,

As presiding officer of the Ormoc City Council may I request your helps in the making of a resolution addressed to President Corazon Aquino and Labor and Employment Secretary Franklin M. Drilon urging them to help resolve soonest the strike in the Aznar's Equatorial Cassava Mill.

I have in 1985 shifted from sugar cane farming to planting of cassava based on a contract with Merelo Aznar as manager of the mill. I have planted 134 hectares and because of the strike my cassava plants are now over-matured, so that tuber deterioration have set in.

At the start of the strike last October, 1987 it was illegal, but subsequent arbitration and hearings thru the DOLE region VIII Reconciliation and Mediation Council the strikers have organized

themselves and thus gained legality. There were many legal manuevers from both sides with no solution to the strike as the strikers continued to demand more everytime management granted certain concessions. At this stage there seems to be an impasse with neither side seriously willing to pursue settlement through the tedious NLRC legal procedures.

As an innocent victim of the strike I wrote to President Aquino whose office endorsed it to DOLE who in turn endorsed the problem to the Region VIII DOLE office with instruction for me to follow it up. This was April 27, 1988 yet. I did not follow up this encouraging lead as there where several moves Merelo Aznar, Atty. Igana, his legal counsel, Carigara Mayor Federico Jacela and I made to solve this problem.

The latest move is based on a contract of lease to operate the mill wherein Mayor Jacela gave the Aznars an advance payment of P350,000.00 last March 28, 1988. A restraining order is to be filled without prejudice to the outcome of the strikers' case since a cash bond to guarantee the payment of the strikers' financial demands will be deposited by Merelo Aznar. Legally this will allow the operation of the mill. But as of today there seems to be an impasse with neither side moving fast and seriously to allow the milling operation. Hence, this my appeal to you and the Ormoc City Council.

Armed with the resolutions of the legislative bodies of Grmoc City and Kananga I will secure a resume' of the proceedings and records of the Reconciliation and Mediation Council in its efforts to resolve this strike. With these three documents I will proceed to Manila to get the attention of the office in President Aquino's administration which kindly endorsed my letter of appeal to DOCS.

Of course, I am not limiting your options to help solve this problem. In whatever official ways to Ormoc City government can help solve this strike will be greatly and heartily appreciated. The strength and influence of your official capacities compared to my puny individual efforts cannot be denied.

I look forward to the grant of my request and whatever helps the City government of Ormoc can extend.
