RESOLUTION NO. 51

A RESOLUTION REQUESTING AUTHORIZATION FROM THE DEPARTMENT OF LOCAL GO-VERNMENT {DLG} TO UTILIZE THE AMOUNT OF THREE THOUSAND THREE HUNDRED THIRTY PESOS {P3,330.00} FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND {EDF} TO BE MADE AVAILABLE TO DEFRAY EXPENSES FOR SNACKS AND LUNCH FOR A ONE-DAY REFRESHER SEMINAR FOR 111 PUNONG BARANGAYS ON PD 1508, ESTABLISHING A SYSTEM OF AMICABLY SETTLING DISPUTES AT THE BARANGAY LEVEL, IN ORMOC CITY, COMPUTED AT P30,00 PER PUNONG BARANGAY PARTICIPANT, ON JUNE 10, 1988, AT THE HON. PLACIDO ENECIO HALL, SANGGUNIANG PANLUNGSOD BUILDING.

"WHEREAS, it has been observed lately that many disputes at the barangay level has not been satisfactorily handled and expedited and less stress has been accorded the realization of amicable settlements in consonance to PD 1508, ESTABLISHING A SYSTEM OF AMICABLY SETTLING DISPUTES AT THE BARANGAY LEVEL, or popularly known as the "Barangay Justice Law.";

"WHEREAS, this has spawned bitter feelings among aggrieved parties within the barangays and has eroded the faith of the people in the barangay system of handling complaints, which, consequently has added an additional workload to our courts of law, the very situation which the Decree was promulgated to avoid;

"WHEREAS, possibly due to the intricacies of the provisions of the Decree, these may be beyond the complete grasp and comprehension of most barangay officials and members of the Lupon Tagapayapa;

"WHEREAS, the DLG of Ormoc City, the Local Administration and the ABC finds it imperative that a refresher seminar be conducted in order to properly guide all concerned with the end in view of proper dispensation of justice and amicable settlements, and most important of all, to maintain the peace and order within the barangays;

"NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., seconded by Kagawad Romeo M. Hermosilla; be it

"RESOLVED, to request authorization from the Department of Local Go-- continued to page 2 - vernments (DLG) Regional Office, Tacloban City, to utilize the amount of Three Thousand Three Hundred Thirty Pesos (P3,330.00) from out of the 20% Economic Development Fund (EDF) to be made available to defray expenses for snacks and lunch for 111 Punong Barangay participants of a refresher seminar on the provisions of Presidential Decree 1508, computed at P30.00 per participant, to be held on June 10, 1988, at the Hon. Placido C. Enecio Hall, Sangguniang Panlungsod Building, Ormoc City, on June 10, 1988;

"RESOLVED FURTHER, to furnish a copy of this resolution each to Mr-Resurrection S. Salvatierra, Regional Director, Department of Local Government, Region 8, Tacloban City; Her Honor, Ma. Victoria L. Locsin, City Mayor, Ormoc City; Mr. Silvestre D. Valencia, Senior Local Government Officer, DLG, Ormoc City, and to Hon. Romeo M. Hermosilla, ABC President, Ormoc City.
