

RESOLUTION NO. 52

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ALLOW OPERATION  
OF ADDITIONAL FIFTEEN (15) UNITS OF MOTORIZED TRICYCLES FOR HIRE  
(MTH) IN THE CITY OF ORMOC.

WHEREAS, it cannot be denied that the population of Ormoc City is increasing very much, as a result thereof, the present number of Motorized Tricycles for Hire (MTH) operating within the City Proper and Suburbs could not meet the need of the riding public so much so that Ormoc City, a center of trade and commerce wherein businessmen travelling interislands pass through Ormoc City;

WHEREAS, no less than the Honorable City Mayor Ma. Victoria L. Locsin requested Hon. Eufrocino C. Codilla, Jr., Chairman on Transportation and Communications, to move for a resolution allowing the operation of additional fifteen (15) units of Motorized Tricycles for Hire (MTH) to make it 500 units all in all;

NOW, THEREFORE, on motion of Kagawad Eufrocino C. Codilla, Jr., seconded by Kagawad Antero T. Fiel; be it

RESOLVED, to authorize the Honorable City Mayor Ma. Victoria L. Locsin to allow the operation of additional fifteen (15) units Motorized Tricycles for Hire (MTH) thus making it 500 units all in all;

RESOLVED, FURTHER, to furnish a copy of this resolution each to the Land Transportation Office, Region VIII, Tacloban City; the Honorable City Mayor; the Land Transportation Office, Ormoc City Agency; the Station Commander, Ormoc City INP; and the City Treasurer; all in Ormoc City.


