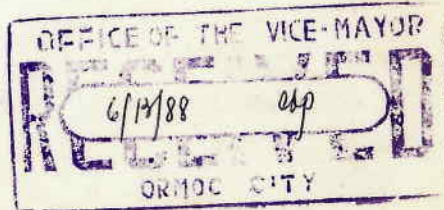

RESOLUTION NO. 53

A RESOLUTION EARNESTLY REQUESTING THE MANAGEMENT OF ABOITIZ SHIPPING CORPORATION TO INSTALL INTAKE AND EXHAUST BLOWERS AT THE THIRD CLASS ACCOMMODATION OF THE M/V ORMOC.

WHEREAS, the Ormoc Consumers Association has manifested their complaint that passenger accommodation in some interisland vessels is below par as far as the comfort and convenience of passengers is concerned, as required by law;

WHEREAS, Kagawad Romeo M. Hermosilla, had the fortunate experience of having been billeted at the third class (3rd) class section of the M/V Ormoc on his way from Cebu to Ormoc on the evening of Tuesday, May 31st, 1988;

WHEREAS, it has been the personal and actual experience of Kagawad Hermosilla that aside from the congested condition of the double deck beds which, in case of emergency, passengers will practically be stymied in their freedom of movement, the said section was sweltering hot and passengers were sweating profusely, even when the vessel was already underway;

WHEREAS, the deplorable condition of such accommodation is, not only very dangerous to the passengers in case of emergency, it also poses a grave threat to the health of the passengers, especially small children due to the absence of proper ventilation;

NOW, THEREFORE, on motion of Kagawad Romeo M. Hermosilla, seconded by Kagawad Antero T. Fiel; be it


RESOLVED, to earnestly request the management of Aboitiz Shipping Corporation, to install intake and exhaust blowers at the third class accommodation of the M/V Ormoc;


