RESOLUTION NO. 57

A RESOLUTION GRANTING THE REQUEST OF THE PROPRIETOR OF NADONGHOLAN COCKPIT TO HOLD A 3-DAY PINTAKASI ON JULY 28, 29, AND 30, 1988, BASED ON THE REQUEST OF MR. PELAGIO T. BRAZIL, JR., CHAIRMAN, ORMOC CITY WEST DISTRICT SCOUTING COMMITTEE, BSP, LEYTE COUNCIL, AREA V; SUBJECT TO THE FAVORABLE APPROVAL OF THE PHILIPPINE GAMEFOWL COMMISSION, TACLOBAN CITY, FOR PURPOSES OF RAISING FUNDS TO DEFRAY EXPENSES OF THE SCOUT AND LAY LEADERS OF THE DISTRICT ATTENDING THE SCOUT AND LAY LEADERS TRAINING PHASE I SOMETIME THIS COMING AUGUST, 1988 AT THE ORMOC CITY CENTRAL SCHOOL, WITH THE CONDITION THAT THIS AUGUST BODY BE FURNISHED A COPY OF THE AUDIT OF THE PROCEEDS THEREOF.

WHEREAS, Mr. Claudio P. Larrazabal, Proprietor, Nadongholan Cockpit, this city, made a communication to this august Body, through the Honorable City Mayor, Ma. Victoria L. Locsin, attaching copy of the letter of Mr. Pelagio T. Brazil, Jr., Chairman, Ormoc City West District Scouting Committee, BSP, Leyte Council, Area V, requesting the former, among others, that they be allowed to sponsor a three (3) day Pintakasi in said cockpit on July 28, 29 & 30, 1988 for purposes of raising funds to defray the expenses of the Scout and Lay Leaders of the district, who will be attending the Scout and Lay Leaders Training Phase I to be held sometime in the month of August, 1988 at the Ormoc City Central School, this city;


