RESOLUTION NO. 63

A RESOLUTION OFFICIALLY INFORMING THE MUNICIPALITY OF KANANGA, LEYTE  
THAT BARANGAY TONGONAN IS PART AND PARCEL OF THE CITY OF ORmoc  
CONSIDERING THAT REPUBLIC ACT 542 CREATING THE MUNICIPALITY OF  
KANANGA, WHICH WAS APPROVED ON JUNE 17, 1950, SPECIFICALLY  
ENUMERATES THE BARRIOS FORMING PART OF SAID MUNICIPALITY AND THAT  
ORIGINALLY TONGONAN WAS PART OF BARANGAY HIBUNAON AS DESCRIBED  
UNDER ORIGINAL CERTIFICATE OF TITLE NO. 30534, DECREE NO. 721535,  
CADASTRAL RECORD NO. 1760 ISSUED IN THE NAME OF THE COMMONWEALTH OF  
THE PHILIPPINES WHICH WAS RESERVED AS A TONGONAN HOT SPRING  
NATIONAL PARK.

WHEREAS, quoted hereunder is Republic Act 542, thus:

"REPUBLIC ACT 542

AN ACT CREATING THE MUNICIPALITY OF KANANGA IN THE  
PROVINCE OF LEYTE

Be it enacted by the Senate and House of Representatives of the  
Philippines in Congress assembled:

SECTION 1. The barrios of Lonoy, Kananga, Rizal, Tugbong,  
Montebello, Agui-ting, Agayayan, Monteslegre, Libungao, Naghalin, and  
Masarayag (now Masarayao) in the City of Ormoc are separated from said  
city and constituted into a new municipality to be known as the  
Municipality of Kananga, with the seat of government at the present site  
of the barrio of Kananga.

SECTION 2. The elective officials of the new municipality shall be  
appointed by the President of the Philippines and shall hold office  
until their successors shall have been elected and shall have duly  
qualified.

(RES. NO. 63)

SECTION 3. This Act shall take effect upon its approval.

Approved, June 17, 1950."

WHEREAS, in the light of the foregoing and as enumerated in said Republic Act 542 this august Body stands pat that Barangay Tongonan is obviously part and parcel of Ormoc City;


NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, seconded by Mga Kagawad Benjamin F. Tugonon, Antero T. Fiel and Romeo M. Hermosilla; be it

RESOLVED, to officially inform the Municipality of Kananga, Leyte, that Barangay Tongonan is part and parcel of the City of Ormoc considering that Republic Act 542 creating the Municipality of Kananga, which was approved on June 17, 1950, specifically enumerates the barrios forming part of said municipality and that originally Tongonan was part of Barangay Hibunaon as described under Original Certificate of Title No. 30534, Decree No. 721535, Cadastral Record No. 1760 issued in the name of the Commonwealth of the Philippines which was reserved as a Tongonan Hot Spring National Park;


RESOLVED, FURTHER, to furnish a copy of this resolution each to the Mr. Ernesto Aboitiz, President, National Power Corporation (NAPOCOR), Diliman, Quezon City; the Philippine National Oil Company (PNOC), PNOC Building, Makati Avenue, Makati, Metro Manila; the Honorable Municipal Mayor and Municipal Council of Kananga, Kananga, Leyte; the Engineer In-Charge, National Power Corporation, Tongonan; the Project Manager, Philippine National Oil Company, Tongonan; the Honorable City Mayor; the Presiding Judge, Regional Trial Court; the Presiding Judge, Municipal Trial Court in Cities; the City Treasurer; the City Legal Officer; the Local Civil Registrar, CPDO; the City Fiscal; the City Assessor; and the Register of Deeds, all in Ormoc City;
