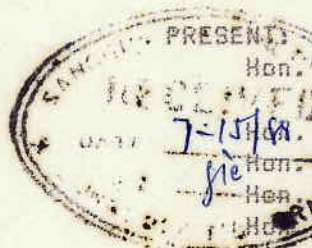

RESOLUTION NO. 64

A RESOLUTION REQUESTING AUTHORIZATION FROM THE DEPARTMENT OF LOCAL GOVERNMENT (DLG) TO UTILIZE THE SUM OF ONE HUNDRED FORTY-EIGHT THOUSAND SEVEN HUNDRED SEVENTY-FIVE PESOS (P148,775.00) FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF) TO BE MADE AVAILABLE AS THE CITY'S 50% COUNTERPART FUNDING FOR THE RURAL SERVICE CENTER PROJECTS; DEEP SEA FISHING, P160,000.00 AND HOLLOW BLOCK MANUFACTURING, P137,550.00, SAID AMOUNT OF P148,775.00 WILL BE RESTORED/RESTITUTED TO THE 20% EDF OF THE GENERAL FUND UPON REIMBURSEMENT OF THE PROJECTS COST FROM THE DLG.

WHEREAS, this august Body is in receipt of the communication of Atty. Roberto C. Omega, City Development Coordinator, this city, addressed to Her Honor, City Mayor Ma. Victoria L. Locsin, requesting, among others, a supplemental appropriation in the amount of P149,000.00 (P148,775.00 is the 50% of the total cost of the projects, per recommendation of the City Budget Officer), as the city's 50% counterpart funding of the proposed projects under the Rural Service Center Project Scheme;

WHEREAS, the city is already in actual receipt of the initial 50% or P148,775.00 from the Rural Service Center;

WHEREAS, it is emphasized that this resolution is for the succeeding 50% (P148,775.00) to complete the project cost of both projects;

WHEREAS, these projects are livelihood projects of the recipient barangays in Ormoc City;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, seconded by Mga Kagawad Eufrocino C. Codilla, Jr., and Romeo M. Hermosilla; be it

RESOLVED, to request authorization from the Department of Local Government (DLG) to utilize the sum of One Hundred Forty-Eight Thousand Seven Hundred Seventy-Five Pesos (P148,775.00) from out of the 20% Economic Development Fund (EDF) to be made available as the city's 50% counterpart funding for the Rural Service Center Projects; Deep Sea Fishing, P160,000.00 and Hollow Block Manufacturing, P137,550.00, said amount of P148,775.00 will be restored/restituted to the 20% EDF of the General Fund upon reimbursement of the projects cost from the DLG;


RESOLVED, FURTHER, to furnish a copy of this resolution each to the Regional Director, Department of Local Government, Tacloban City for his immediate consideration and approval; the Honorable City Mayor; the City Development Coordinator, City Planning and Development Office; the Senior Local Development Officer, City Development Office, DLG; the City Treasurer; and the City Budget Officer, all in Ormoc City;
