

RESOLUTION NO. 66

A RESOLUTION EARNESTLY SUPPLICATING HER EXCELLENCY PRESIDENT CORAZON C. AQUING TO ACCEDE TO THE REQUEST OF THE BARANGAY COUNCIL AND RESIDENTS OF BARANGAY CAMP DOWNES LOCATED AT THE MILITARY RESERVATION OF CAMP DOWNES, ORMOC CITY, THAT THE LOTS WHEREIN HOUSES ERECTED AS RESIDENCES OF PRESENT OCCUPANTS, FAMILIES OF PERSONNELS IN THE ACTIVE SERVICE OF THE NEW ARMED FORCES OF THE PHILIPPINES, RETIRED MILITARY PERSONNELS AND VETERANS, AND SOME CIVILIANS WHO ARE SURVIVING FAMILY MEMBERS OF DECEASED MILITARY PERSONNELS WHO HAD BEEN LIVING IN THE MILITARY RESERVATION FOR MANY YEARS; BE SOLD ON INSTALLMENT BASIS OR LEASED TO THE ACTUAL OCCUPANTS THEREIN.

WHEREAS, Resolution No. 13, Series of 1988 of the Barangay Council of Barangay Camp Downes and a petition signed by 207 residents of said barangay requesting this august Body thru the Honorable City Mayor Ma. Victoria L. Locsin to make representation for and in behalf of the Barangay Council and residents therein to Her Excellency President Corazon C. Aquino that the lots in Barangay Camp Downes located at the military reservation where houses are erected, be sold on installment basis or leased to the actual occupants of these residential houses - a meticulous study and investigation regarding this resolution request and petition was conducted by the Kagawad In-Charge of said barangay Hon. Antero T. Fiel;

WHEREAS, there are more than Two Thousand inhabitants living in said military reservation, 30% of whom are families of personnel who are in the active service of the New Armed Forces of the Philippines, 50% are families of retired military personnels and veterans, and about 20% are civilians who are surviving family members of deceased military personnel who had been living in said military reservation for many years long before said area was created as a barangay of Ormoc City and even many years before World War II;

WHEREAS, the inhabitants of said barangay are occupying 200 semipermanent houses in said military reservation along the seashore on the West side of the National highway and on the East side of said highway below the slopes of the hill and plateau of the said military reservation of Camp Downes of which the lots to be alienated and sold or leased does not affect, hamper or impede the activities of the military personnel because the camp with its headquarters, barracks and wide training grounds is located on a plateau;

WHEREAS, during dialogues with the PC Provincial Commander; the Commanding Officer, 352nd PC Company; and some officers and non-commissioned officers of the military reservation; majority of whom concede that the request is reasonable and nobody aired any objection to the resolution request of the Barangay Council and residents of Barangay Camp Downes;

WHEREAS, after a meticulous study and deliberate action the Kagawad In-Charge, Barangay Camp Downes, strongly aired his opinion that this resolution request of the Barangay Council and petition of the residents of Barangay Camp Downes is considered to be suitable and acceptable, that it is but fitting and proper that the members of this august Body affirm, uphold and support the request for the best interest of the people;

NOW, THEREFORE, on motion of Kagawad Antero T. Fiel, jointly seconded by Mga Kagawad Gregorio A. Yrastorza, Jr. and Eufrocino C. Codilla, Jr.; be

RESOLVED, to pass a resolution earnestly supplicating Her Excellency President Corazon C. Aquino to accede to the request of the Barangay Council and residents of Barangay Camp Downes located at the military reservation of Camp Downes, Ormoc City, that the lots wherein houses erected as residences of present occupants, families of personnels in the active service of the New Armed Forces of the Philippines, retired military personnels and veterans, and some civilians who are surviving family members of deceased military personnels who had been living in the military reservation for many years; be sold on installment basis or leased to the actual occupants therein;

RESOLVED, FURTHER, to furnish a copy of this resolution each to the Secretary of National Defense, Hon. Fidel V. Ramos; the Chief of Staff of the New Armed Forces of the Philippines, General Renato de Villa; the Commanding General of the Philippine Army, NAFP, Maj. Gen. Mariano M. Adalem; the Commanding Officer of the 8th Regional Community Defense Unit, Gen. Lorenzo Mateo; the Philippine Constabulary Provincial Commander, Col. Diony Ventura; the Commanding Officer, 352nd PC Company, Maj. Senador Jacob; the Station Commander, Phil. Coast Guard Grmoc City, LTJG. Edgardo C. Ingking; the ABC President, Hon. Romeo M. Hermosilla; the Barangay Captain and Barangay Council members of Barangay Camp Downes, Ormoc City.
