A RESOLUTION DIVIDING ORMOC CITY INTO ELEVEN REPRESENTATIVE DISTRICTS
AND APPORTIONING THE SAME AMONG THE HONORABLE VICE-MAYOR AND
PRESIDING OFFICER AND HONORABLE MGA KAGAWAD OF THE FIFTH
SANGGUNIANG PANLUNGSOD NG ORMOC.

"WHEREAS, it is incumbent upon the Vice-Mayor & Presiding Officer
and Mga Kagawad of this august Body foremost and above all to serve the
best interest of the majority of our constituents of Ormoc City;

"WHEREAS, as mandated by the people, the stupendous task that this
august Body embarks upon demands for its success every ounce of its
energy and the spirit of dedicated service;

"WHEREAS, at a momentous period like this, it behooves every
member of this august Body to do his share in the great efforts of city
development and serving the people;

"WHEREAS, after a thoughtful deliberation and meticulous study, in
order that the people of Ormoc can be earnestly and sufficiently served,
it has become imperative to divide Ormoc City into eleven representative

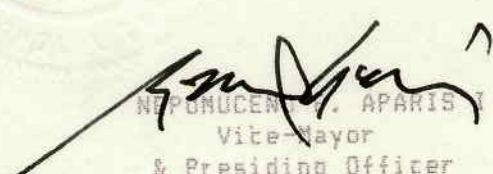
