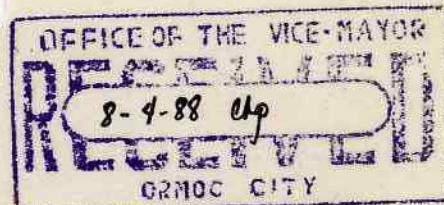

RESOLUTION NO. 72

A RESOLUTION AMENDING RESOLUTION NO. 6, SERIES OF 1988, PARTICULARLY THE COMMITTEES ON MANPOWER DEVELOPMENT, RURAL DEVELOPMENT AND BARANGAY AFFAIRS, AND URBAN DEVELOPMENT; THE FOREGOING BE CHAIRED BY HONORABLE ROMEO M. HERMOSILLA; THEREUPON THE FORMER CHAIRMEN TO ASSUME AS VICE-CHAIRMEN AND THE FORMER VICE-CHAIRMEN AND MEMBERS AS MEMBERS THEREOF.

WHEREAS, Honorable Romeo M. Hermosilla, representing the Association of Barangay Councils (ABC) is already a full-pledged kagawad (member) by virtue of the Memorandum dated May 3, 1988 issued by the Honorable Secretary of the Department of Local Government designating him as Kagawad (Member) of the Sangguniang Panlungsod ng Ormoc (ABC Representative), with authority to discharge the duties and functions vested in said august body in accordance with law, but until now no committee has been assigned to Hon. Romeo M. Hermosilla although a few months have elapsed from the time of his assumption to office;

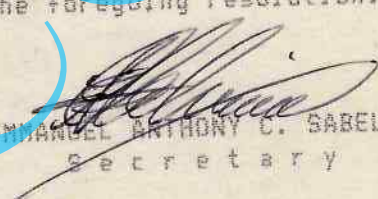

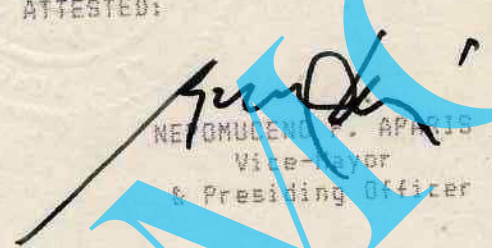
