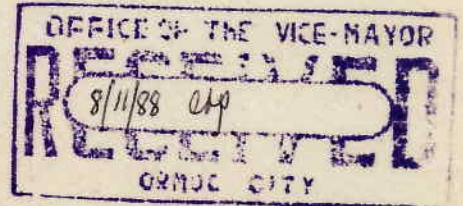

RESOLUTION NO. 75

A RESOLUTION REQUESTING AUTHORIZATION FROM THE DEPARTMENT OF LOCAL GOVERNMENT (DLG) TO AUTHORIZE THE HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN TO UTILIZE THE AMOUNT OF EIGHTEEN THOUSAND PESOS (P18,000.00) FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF) - CONTINUING APPROPRIATION - TO DEFRAY EXPENSES FOR THE IMMEDIATE REPAIR AND REHABILITATION OF TWO (2) UNITS NON-SERVICEABLE MOTORCYCLES ACQUIRED BY THE CITY GOVERNMENT OF ORMOC FROM THE POPULATION COMMISSION (POPCOM), REGION VIII, TACLOBAN CITY, FOR USE OF THE CITY TREASURER'S OFFICE AND THE ORMOC CITY WATERWORKS COLLECTION OF TAXES AND OTHER FEES.

WHEREAS, the City Government of Ormoc, through the Honorable City Mayor Ma. Victoria L. Locsin is a recipient of two (2) units non-serviceable motorcycles from the Population Commission (POPCOM) Office, Region VIII, Tacloban City;

WHEREAS, in order that these units be serviceable it naturally needs repair and rehabilitation;

WHEREAS, it is imperative to ask authorization from the Department of Local Government to authorize the Honorable City Mayor Ma. Victoria L. Locsin to utilize the amount of P18,000.00 from the 20% Economic Development Fund (EDF) - a continuing appropriation - for the immediate use of the City Treasurer's Office and Ormoc City Waterworks in relation to their respective drive to enhance collection of taxes and other fees;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, severally seconded by Mga Kagawad Eufrocino C. Codilla, Jr., Gregorio A. Yrastorza, Jr., Arnulfo C. Salazar and Romeo M. Hermosilla; be it

RESOLVED, to earnestly request authorization from the Department of Local Government (DLG) to authorize the Honorable City Mayor Ma.


