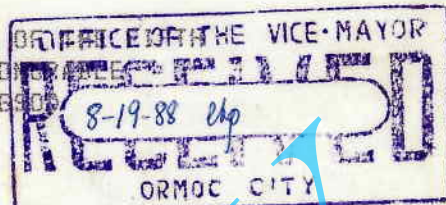

RESOLUTION NO. 77

A RESOLUTION REQUESTING THE HONORABLE ALICE REYES, CHAIRPERSON, PHILIPPINE AMUSEMENT GAMES CORPORATION, MANILA, TO ASSIST AND ALLEVIATE THE PROBLEM ON ENFORCEMENT OF LAW AND ORDER IN THE CITY OF ORMOC BY WAY OF DONATING VEHICLES TO THE ORMOC CITY INP.

WHEREAS, quoted verbatim hereunder is a copy of the communication of the Honorable City Mayor of Ormoc, dated August 4, 1988, addressed to the Honorable Alice Reyes, Chairperson of the Philippine Amusement Games Corporation, thus:

Dear Hon. Reyes,

Foremost of the problems of enforcement of law and order is the lack of mobility. This is true in the Integrated National Police force of our city. Our police has only one (1) vehicle to serve the entire City of more than 120,000 population. With this acute problem, reaction to emergency calls is very slow and efforts for law enforcement is hampered.

This problem should be a joint concern of the City Government and the INP-PC but with the financial constraints we have wherein we barely meet the other priority needs of our constituents, we have to seek out other offices to help us in this regard.

Knowing that your office is also concerned with the upliftment of the various services in the government, we would like to solicit your assistance to alleviate this problem.

We sincerely hope you could help us solve at least one of the many problems we have. I'm sure any assistance you could extend will be well appreciated by the Ormocanons.


