A RESOLUTION REQUESTING AUTHORIZATION FROM THE DEPARTMENT OF LOCAL GOVERNMENT (DLG) TO AUTHORIZE THE HONGRABLE CITY MAYOR MA. VICTORIA L. LOCSIN TO UTILIZE THE AMOUNT OF FIFTEEN THOUSAND PESOS (P15,000.00) FROM OUT OF THE ZOZ ECONOMIC DEVELOPMENT FUND (EDF) - CONTINUING APPROPRIATION - FOR THE FOLLOWING; P7,000.00 FOR VARIOUS EXPENSES IN REORGANIZATION AND REACTIVATION GF THE BARANGAY DEVELOPMENT COUNCILS AND IN THE CONDUCT OF BRIEFING/CONFERENCES PREPARATORY TO THE FORMULATION OF THE COMPREHENSIVE DEVELOPMENT PLANS IN THE DIFFERENT BARANGAYS OF ORMOC CITY AS ENUNCIATED IN EXECUTIVE ORDER NO. 319 DATED MARCH 4, 1988 AND P8,000.00 FOR 1988 ORMOC CITY S CONTRIBUTION TO THE REGIONAL DEVELOPMENT COUNCIL (RDC), EASTERN VISAYAB REGION, PER RDC RESOLUTION NO. 5, SERIES OF 1988.

WHEREAS, the Senior Local Sovernment Officer, City Development Office, DLG, Ormoc City, in his communication dated July 29, 1988 has requested for an appropriation of P7,000.00 for various expenses in the reorganization and reactivation of the Barangay Development Councils and the conduct of briefing/conferences preparatory to the formulation of the Comprehensive Development Plans in the different barangays of Ormoc City as enunciated in EO No. 319 dated March 4, 1988;

WHEREAS, based on RDC Resolution No. 5, Series of 1988, RDC member agencies and local government units shall contribute P8,000.00 each annually:

WHEREAS, it is imperative to ask authorization from the Department of Local Government to authorize the Honorable City Mayor Ma. Victoria L. Locsin, to utilize the amount of P15,000.00 from out of the 20% Economic Development Fund (EDF) - a continuing appropriation - for the above-mentioned purposes;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, seconded by Mga Kagawad Antero T. Fiel and Celso P. Porcadilla; be it

RESOLVED, to request authorization from the Department of Local Government (DLG) to authorize the Honorable City Mayor Ma. Victoria L. Locsin, to utilize the amount of Fifteen Thousand Pesos (P15,000.00) from out of the 20% Economic Development Fund (EDF) - a continuing appropriation - for the following: P7,000.00 for various expenses in the reorganization and reactivation of the Barangay Development Councils and in the conduct of briefing/conferences preparatory to the formulation of the Comprehensive Development Plans in the different barangays of Ormoc City, as enunciated in EO Mo. 319 dated March 4, 1988, and P8,000.00 for 1988 Ormoc City's contribution to the Regional Development Council (RDC), Eastern Visayas Region; per RDC Res. Mo. 5, Series of 1988;
