RESOLUTION NO. 82

A RESOLUTION ADOPTING RESOLUTION NO. 85, SERIES OF 1988 OF THE HONORABLE SANGGUNIANG PANLALAWIGAN OF PANPANGA, URGING CONGRESS TO ENACT A LOCAL GOVERNMENT CODE THAT WILL PROVIDE A GENUINE AND AUTHENTIC SYSTEM OF DECENTRALIZATION INCORPORATING, AMONG OTHERS, SEVEN (7) ISSUES WHICH ALSO SERVED AS THE FRAMEWORK FOR THE DEPARTMENT OF LOCAL GOVERNMENT DECENTRALIZATION PLAN.

WHEREAS, this august Body is in receipt of Resolution No. 85. Series of 1988 of the Honorable Sangguniang Fanlalawigan of Pampanga, for adoption, urging, among others, Congress to enact a Local Government Code that will provide a genuine and authentic system of decentralization incorporating, among others, seven (7) issues which also served as the framework for the Department of Local Government Decentralization Plan;

WHEREAS, this august Body conforms, concurs and adheres in the embodiment of said Resolution No. 85, Series of 1988 of the Honorable Sangguniang Panlalawigan of Pampanga:

THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., seconded by Kagawad Arnulfo C. Salazar; be it

RESOLVED, to adopt Resolution No. 85, Series of 1988 of the Honorable Sangguniang Panlalawigan of Pampanga, and do as this Body hereby does, urge Congress to enact a Local Government Code that will provide a genuine and authentic system of decentralization incorporating among others, seven (7) issues which also served as the framework for the Department of Local Government Decentralization Plan, thus:

- Full control by local units of resources, local as well as those alloted by the national agencies;
- Authority over national agency functionaries;

- Flexibility to formulate and execute decisions based on sociocultural factors;
- People empowerment which would ensure participation of nongovernmental organization in all possible fields of local governance;
- 5. Power to exhaust all legal means to improve financial resources;
- Authority to allocate resources to address basic, minimum needs of local community; and
- 7. Seek block grants to financially assist local governments.

RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Senate President, House of the Senate and the Honorable Speaker of the House, House of the Representatives, Congress of the Philippines, Manila; the Honorable Sangguniang Panlalawigan of Pampanga, Capitol Building, San Fernando Pampanga; and the Honorable City Mayor, Ormoc City;
