

RESOLUTION NO. 83

A RESOLUTION REQUESTING AUTHORIZATION FROM THE DEPARTMENT OF LOCAL GOVERNMENT (DLG) TO AUTHORIZE THE HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN, TO UTILIZE THE AMOUNT OF THREE HUNDRED SEVENTY THOUSAND FIVE HUNDRED PESOS (P370,500.00) FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF) FOR THE FOLLOWING PURPOSES: P363,500.00 TO BE MADE AVAILABLE TO COVER THE CITY GOVERNMENT'S COUNTERPART FOR ALL SPECIAL DEVELOPMENT ACCOUNT (SDA) - FUNDED PROJECTS IN ORMOC CITY AND P7,000.00 FOR ASBI-RWSA PRE-OPERATIONAL TRAINING/SEMINAR OF OFFICERS AND MANAGEMENT STAFF OF ASBI.

WHEREAS, the City Treasurer in his letter dated July 5, 1988 has requested for a supplemental appropriation of Three Hundred Sixty-Three Thousand Five Hundred Pesos (P363,500.00) to cover the city government's counterpart for all Special Development Account (SDA) - funded projects in Ormoc City; conditioned, however, on the restitution of same amount to 20% EDF of the General Fund upon reimbursement of cost from the DLG;

WHEREAS, the Development Project Analyst of the City Planning and Development Office, in his letter dated August 9, 1988 has requested also, for budgetary requirement and/or expenses, as city's counterpart for ALTA VISTA - SUMANGGA - BANTIGUI - IPIL- Rural Waterworks Sanitation Association (ASBI-RWSA) Pre-Operational training/seminar of Officers & Management Staff of ASBI, of which the City Budget Officer recommended P7,000.00 be taken from the 20% Economic Development Fund (EDF) - continuing appropriation to serve the purpose;

WHEREAS, this august Body finds it imperative to ask authorization from that level to authorize the Honorable City Mayor Ma. Victoria L. Locsin to utilize the amount of P370,500.00 from the 20% Economic Development Fund (EDF) for purposes herein above-mentioned;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, jointly seconded by Mga Kagawad Eufrocino C. Codilla, Jr. and Romeo M. Hermosilla; be it

RESOLVED, to earnestly request authorization from the Department of Local Government (DLG), through the Regional Director, Region VIII, Tacloban City, to authorize the Honorable City Mayor Ma. Victoria L. Locsin, to utilize the amount of THREE HUNDRED SEVENTY THOUSAND FIVE HUNDRED PESOS (P370,500.00) from out of the 20% Economic Development Fund (EDF) for the following purposes:


- P363,500.00 (a continuing appropriation of the General Fund) to cover the city's counterpart for all Special Development Account (SDA) - Funded projects in Ormoc City;

- P7,000.00 for ASBI-RWSA Pre Operational training/seminar of Officers and Management Staff of ASBI.




